The Biden-Harris administration is working quickly to make changes that help workers, support education, and to get through the pandemic quickly and safely. As we await long overdue guidance from the CDC on safe school building opening, we find ourselves in the middle of a philosophical war between parents who want school buildings open with no regard to safety measures and other Americans who are demanding safety. Most of us want more virus mitigation efforts and, frankly, want society to respect us and value our lives. We have become the villain in some versions of this story--when the real enemy is the pandemic. I know that many of our members are near a breaking point. I'm sorry. Resilience is what we get us through this time and resilience is a learned skill-please don't doubt your capacity for resilience!

Now it is more important than ever to organize and advocate for our members. We know that teachers and staff, preschool through higher education, all want to be in the classrooms with our students. We also

know that we have the right to be safe and, without a national strategy or statewide guidance, many of our districts have fallen short in their responsibility to keep their staff and faculty safe. AFT has resources and experts to help us advocate for our members and ensure safety precautions are being followed. The CDC has promised quidance to be published any day now-look to AFT for support with getting safety measures implemented in your district or school. The NFL has been successful in preventing COVID outbreaks and the CDC published a case study. One thing we have learned from this is that there are four quadrants of mitigation: distance, time, mask use, and ventilation. If we can't successfully meet at least two of the four, we are not safe.

Thank you for your solidarity during this extraordinary time. Together we are stronger.

COVID 19 Vaccine for Educators

On January 29, 2021, Governor Jared Polis held a meeting for Pre K-12 union members to share the exciting news that, beginning February 8, all Pre K-12 educators will start receiving their COVID-19 vaccines. Governor Polis believes that, by the end of February, all educators (teachers and staff) will have received their first dose of the vaccine.

Additionally, he shared information about the BinaxNOW COVID-19 at-home testing. Your school district should be communicating information regarding the BinaxNOW testing procedure soon.

Your school district will also send out information regarding the scheduling of your vaccination with a health care provider. However, if you are on the waitlist at Kaiser, you may be hearing directly from Kaiser.

- State Government
- Members of the Executive, *Legislative, and Judicial branches of government.

Beginning on February 8, everyone in Phase 1B.2 will be eligible to receive the vaccine.

Legislative Updates and Actions



Due to ongoing concerns surrounding the coronavirus pandemic, the Colorado General Assembly will delay the start of the 2021 legislative session until the third week of February. The General Assembly did meet briefly in January to pass a handful of non-education related COVID-relief bills.

There is information trickling out of the legislature on bills that will be considered and we have identified one particular issue that requires your attention. There likely will be a bill introduced that would instruct the Colorado Department of Education to request a waiver from the federal government's requirement under the Every Student Succeeds Act (ESSA) to perform standardized testing during the 2021-2022 school year. Read this article from the Colorado Sun about the ongoing debate over testing.

As you know, the past two school years have been anything but normal. We have been listening to feedback from members telling us that now is not the time to divert focus away from instructional time for standardized testing. So our response, in collaboration with the Colorado Education Association, has been to put together a petition campaign urging the Colorado General Assembly to cancel 2021 CMAS testing. And as we begin this year's legislative session, we would also urge you to send a personal message to <u>your representatives</u> telling them that the best thing for our students is to pause CMAS testing during the 2021-2022 school year.




Local Union Updates
